

Cookie Notice

I.- Introduction

Based on the User's consent, our Website uses cookies and similar tracking technology for the purposes detailed below. We ask You to carefully read the following information regarding how we process your personal data via the use of cookies.

For the purposes of this Cookie Notice, “**User**” or “**You**” shall be understood as any natural person who uses the Website. You are hereby informed that third party cookies used on the Website are not controlled by Us but by the corresponding third party. You will find detailed information on the third parties that install cookies on the Website under Section IV.

II.- What is a cookie? What do We use them for?

Cookies are small text files that are sent by the Website and stored on the User’s hard drive, allowing the Website to recognize the User and store certain information about You. For instance, depending on your preferences, cookies may analyse site traffic, remember your preferences, and personalize content.

Cookies are used to collect information about the User's navigation in order to provide our services, to measure the performance of our Website, as well as to show You personalized advertising related to your preferences, by obtaining data necessary to profile your browsing habits, such as pages visited, frequency of access, time spent browsing websites and similar parameters. Again, please note that this will heavily vary depending on your specific preferences and cookie settings.

III.- Categories of personal data processed

Although this will vary depending on your specific preferences and configuration, the data that We collect and process via the use of cookies includes the following usage and device-related data:

- The date and time of the last time the User visited our Website,
- The content that You viewed during your first visit to our Website,
- Your preferred default language.
- Your device type, operating system and version, browser type and settings, IP address or other individual device identifier and individual device token,
- Your user segment (e.g., your behavioural patterns, preferences, or purchase history).

In the event that You choose to accept the personalization cookies, We may combine your personal data with other information to gather information about your interests and activities, as explained in Section IV.

IV.- Types of cookies that We use

First, note that there are two essential types of cookies: (i) that ones that We use, which are our own cookies, and (ii) the ones used by third parties.

- Own cookies: these are those sent from our Website to your terminal. This helps Us provide You with the services You requested,
- Third-party cookies: these are those sent from a domain that We do not manage to your terminal, and they manage the data they retrieved from your specific cookies.

We use the following cookies that may require Your consent, depending on the specific category:

V.- For how long will We store the information collected through cookies?

We want to let You know that the data derived from the installation of cookies will be used solely and exclusively for the time necessary to fulfil the purposes for which they have been indicated, depending on the type of cookie. With regard to our own cookies, they will not have an expiration date of more than a year from the moment where You consented to its installation. Note that we may need to store this data duly blocked until the prescription of any potential claims.

Equally, even if the cookie has expired, We may renew it if You accept its use again.

VI.- With whom will We share the information collected through cookies?

We may share the data obtained through the installation of cookies on the Website with the following categories of recipients:

- Service Providers: We have service providers that assist in the management, analysis and continuous improvement of the Website.
- Third parties that install cookies on the Website: The entities that install their cookies on the Website will use the data collected through their cookies for their specific purposes indicated above.

Please note that some of the aforementioned service providers are located in countries outside the European Economic Area ("EEA"), and may not initially offer a level of security equivalent to that which exists in our territory, as mandated by the applicable data protection regulation. These countries may include, for example, the country of establishment of the third-party cookie owners that collaborate with Us in the use and installation of cookies, detailed in Section IV.

In these cases, the transfers will be based on the standard model clauses pre-approved by the European Commission, according to article 46.2 c) EU General Data Protection Regulation. For more information about the above safeguards or the fact that they have been provided, You may contact Us by the means set out in Section I.
